To Whom It May Concern:

I write to provide a legal reference for Dr. G. Keith Still. We engaged Dr. Still to assist in a complex litigation matter involving an alleged crowd incident which occurred as guests were exiting a sporting event at a large arena in Las Vegas, Nevada, USA. In searching for the appropriate expert, I was initially impressed with Dr. Still's background having studied, researched, and advised extensively in the area of crowd behavior and crowd management. Dr. Still certainly is a wealth of knowledge in these areas. However, as I worked further with Dr. Still, I became increasingly impressed with his attention to detail.
